3. Description of Proposed Standard or Enhancement: Request for Pooling Quantity:

 To provide the Service Requester (i.e. pooler) with the ability to request pooling information for any specified time period. The request will allow the pooler to obtain the Scheduled Quantity for Poolers Documents (see below) with pooling information a.) for past periods, b.) for future periods or, c.) for retransmissions of current periods. This proposed standard uses the R96009B Workpaper as its basis.

In addition to the data elements used in R96009B, ANR requests that a new data element be added for <u>contract</u>. With the data elements requested in R96009B and the new <u>contract</u> data element, the pooler will be able to request one or all pooling contracts for a pooling location. The Request for Pooling Quantity transaction set should be implemented at the same time as the following changes to the Scheduled Quantity for Operator (Pooler) changes.

Scheduled Quantity for Poolers:

- The transaction dataset requirements are based on the Scheduled Quantity for Operators (G865SQOP) transaction dataset.

1.) The data elements required for the pooling information are currently in G865SQOP, except the following:

-Receipt Rank -Delivery Rank

2.) It is thought that the current G865SQOP dataset could be used for this purpose by adding a Pooling code value for BCA13 Purchase Order Type Code. (Example of data elements and sample data attached)

4. Use of Proposed Standard or Enhancement:

To accommodate ANR's survey item No. 14 for Pool Market Summary, the Request for Scheduled Quantity for Operator (R96009B) and the Scheduled Quantity For Operator Transaction Sets may be used.

ANR's survey item No. 14 for Pool Market Summary:

The Pool Market Balance Summary: SR (pooler) needs to request a list of Pool Market information by pooling contract (includes the following criteria: by specific date and flow time, pooling contract, headstation location). The response by TSP includes the daily supply, pool market and longhaul volumes nominated for the pool. This data will allow SR (pooler) to determine pooling variances and balance pools prior to nomination. Supply detail includes upstream Contract ID, nominated volumes and ranks. Market detail includes longhaul Contract ID, nominated volume and ranks.

5. Description of Any Tangible or Intangible Benefits to the Use of the Proposed Standard or Enhancement:

Provides for determination of out of balance pools prior to start of nomination cycle.
