3. Description of Proposed Standard or Enhancement:

New standard data sets are requested under the GISB Capacity Release Related Standards (5.4.X) to accomplish the recall and reput of released capacity.

4. Use of Proposed Standard or Enhancement:

Capacity release recalls and reputs are allowed under GISB Standards 5.3.6, 5.3.7, and 5.3.8. For the Submitting Entities, these functions are currently accomplished interactively on their proprietary EBBs. It is believed that these functions could be accomplished via EDI/EDM through the creation of ANSI X.12 EDI data sets such as the Upload of Recall, the Upload of Reput, and Associated Documents (Recall and Reput Quick Responses, and accompanying Notification, Validation, and Final Disposition documents). The Submitting Entities believe that these functions could also be accommodated on the Customer Activities Web pages (EBB/EDM) or flat files (FF/EDM).

5. Description of Any Tangible or Intangible Benefits to the Use of the Proposed Standard or Enhancement:

Provides standardized methods for recalling and reputting released capacity.

6. Estimate of Incremental Specific Costs to Implement Proposed Standard or Enhancement:

Costs of implementation should be those typically associated with the development, testing and mapping of new transaction sets.
